- Fundraiser forms – Nicole Pereira reviewed forms and which one to use – need money in fund prior to items being purchased, can not front money, Karen Pendergast to email coaches balance of funds
- Winter Concession Stand: School classes to handle concession stand – booster club not to man concession stand – Stacia Leavitt suggested that fundraisers need to be pushed, where concession stand made up part of the general fund

- Athletic Trainer: funds from sale of banners was used to pay trainer fee last year – cost: 4500 full year, trainer under contract, school dept. paid trainer and boosters reimburse school – voted to pay trainer for winter/spring season, and tabled discussion until minutes of 2012 reviewed
- Scholarships: available to student athletes – 6 scholarships awarded – 3 boys/3 girls – scholarships paid out of general fund  
was suggested that scholarship committee should have perimeters – tabled to march meeting to vote on scholarships
